ARTICLES OF INCORPORATION

OF

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be Nancy Young, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be Waterside Shops, Space G-14, 5415 Tamiami Trail North, Naples, Florida 34108, and the mailing address shall be the same.

ARTICLE III CAPITAL STOCK
