Attached are copies of forms and letters ^{prepared} ~~submitted~~ previously intact.

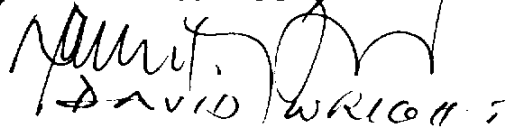
