This corporation is authorized to issue 100 shares of ONE DOLLAR (\$1.00) par value common stock.

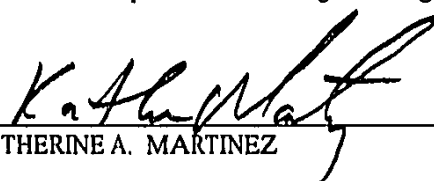
