

ARTICLES OF INCORPORATION
OF
NORTH AMERICAN COLLISION CENTERS, INC.

The Undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name and principal address of the corporation is NORTH AMERICAN COLLISION CENTERS, INC., at Suite 492, 1489 West Palmetto Park Road, Boca Raton, Florida 33486.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

The corporation may transact any and all lawful business for which corporations may incorporate under the Florida General Corporation Act.

ARTICLE FOUR

CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is one hundred thousand (100,000), all of which shall be common shares with a par value of One Dollars (\$1.00).

PRE-EMPTIVE RIGHTS GRANTED

ARTICLE SEVEN

The Board of Directors of the Corporation shall consist of two. The number of directors is to be set by the shareholders at a meeting called for that purpose.




