The undersigned, for the purpose of forming a corporation under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

**ARTICLE I - NAME AND OFFICE BUSINESS ADDRESS**

The name of this corporation is LSR CAPITAL CORP. The principal business and mailing address for the Corporation is 5513 North Military Trail, #715, Boca Raton, Florida 33496.

**ARTICLE II - DURATION**

This corporation shall exist in perpetuity.

**ARTICLE III - PURPOSE**
