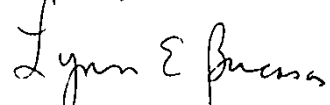
To Whom It May Concern;

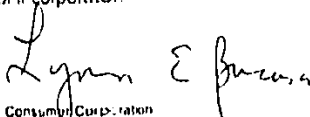
