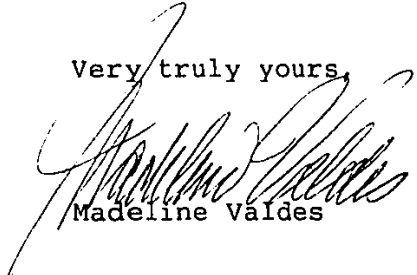

FOR

The corporations's principal address and the registered office address are the same. The address is:

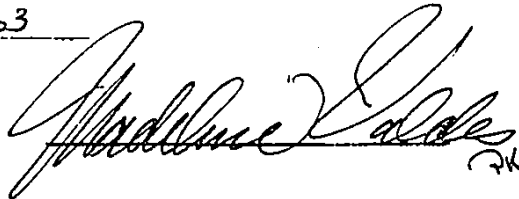

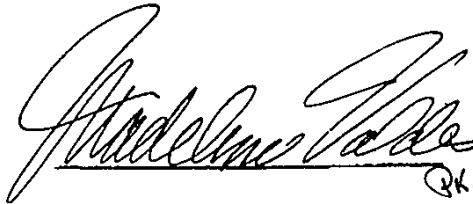

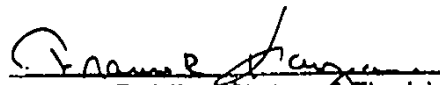
