ARTICLES OF INCORPORATION

I, the undersigned incorporator, for the purpose of forming a professional service corporation under sections 607 and 621 of the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares.


ARTICLE V - INITIAL REGISTERED AGENT AND ADDRESS


