Pursuant to discussions with your office by telephone, this letter is a request for reinstatement of the above named corporations, and a waiver of the \$600.00 fee due for reinstatement after involuntary dissolution.

Sawyer-McCoy Enterprises was dissolved last year, and it appears J. Michael Sawyer, PA may have been dissolved even a year or two earlier. I am requesting this consideration from the Department as it has come to my attention that the normal annual renewal fees on these corporations were not paid due to fraud and theft on the part of the former bookkeeper for both corporations. Apparently, numerous checks for both of these corporations were written by the bookkeeper with one name on the check stub, and her own name on the actual check. Upon there return in the bank statement, these checks were then disposed of by the bookkeeper to prevent discovery. This apparently included checks written to the Department of State for annual renewal fees, and in some cases checks were not written at all despite the indication that the fees had been paid.

While I understand the Department of State is under no obligation to grant this waiver, I am respectfully requesting that the substantial reinstatement fees be waived for these two corporations on a one-time basis. Please inform me as soon as possible of your decision, and of what fee you do expect to be paid, and I will see that these corporations immediately forward to you the required fee for reinstatement.
