Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, UNIVERSITY OF ORLANDO GRADUATE SCHOOL, INC. adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is UNIVERSITY OF ORLANDO GRADUATE SCHOOL, INC.
2. The original Articles of Incorporation for the corporation were filed on April 9, 1997, and assigned Charter No. P97000032186.
3. By written consent executed on 9/9/97, 1997 by the sole Director and sole Shareholder of the corporation, respectively, the sole Director and sole Shareholder has agreed that the Articles of Incorporation be amended to change the name of the Corporation to "UNIVERSITY OF ORLANDO GRADUATE SCHOOL, INC." The amendment was approved by the sole Shareholder of the single class of stock of the Corporation.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this corporation is FLORIDA TECHNICAL COLLEGE OF AUBURNDALE, INC.
