The undersigned, acting as the incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME: The name of the Corporation is: L.A.N., INC.

ARTICLE II

PRINCIPAL ADDRESS
