CORPORATE NAME

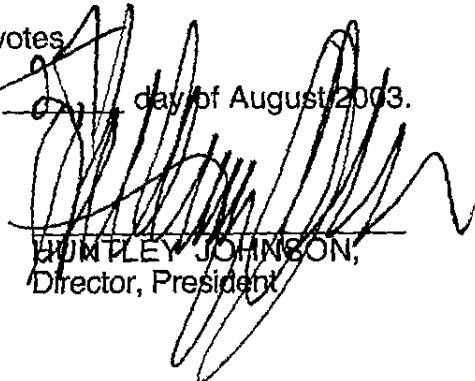
The name of the corporation shall be JOHNSON, VIPPERMAN, JENKINS & UMAN, P.A.
