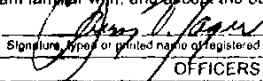

TO WHOM IT MAY CONCERN:

At the recommendation of one of your staff, whom I called and talked with today, enclosed please find my check for \$150.00, plus this letter of explanation relative to the fee paid.

The 1998 Profit Corporation Annual Report packet was sent to another address, then forwarded to me, which I received yesterday. This packet was marked "2nd Notice". I never received the "First Notice", which apparently also went to the wrong address, but was never forwarded.

There is a possible explanation for this. When the corporation was formed, I had a partner, Mr. Richard W. Carritt, who was President of our company. Unbeknown to me, when incorporating our business he listed his personal address, rather than our business address. On July 29, 1997, I bought out Mr. Carritt's interest in the business. Consequently, when you sent out the original notice it went to Mr. Carritt at his personal address and he never informed me of same nor forwarded the packet to me, whether intentional or not.

Therefore, as suggested by the person in your office that I spoke with, I am requesting that you accept the enclosed check for \$150.00, and not assess the late filing penalty fee.

If necessary, I will be happy to furnish you proof (i.e. copy of Purchase Agreement) that I bought out Mr. Carritt's interest in the business. I have also attached a copy of the address portion of the packet that was just forwarded to me.

Your favorable consideration of my request would be greatly appreciated. I never was aware of the first notice sent.
