We, the undersigned, with other persons being desirous of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, do agree to the following:

ARTICLE I. NAME

The name of the corporation shall be:

H.J.S. LIFT STATION SERVICES, INC.

The address of the principal office of this corporation shall be 1526 Creekbend Drive, Brandon, Florida 33510, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
