The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Sports Enterprises, Inc., and its address is 834 S.W. 30th Street, Apartment 2, Ft. Lauderdale, Florida 33315.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are:

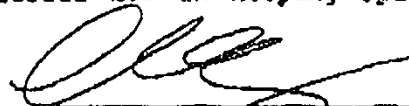
