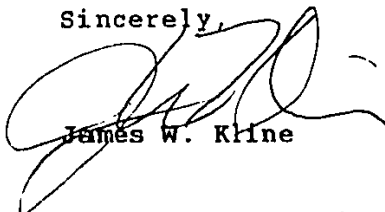

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation shall be:

KAMBUCK RESOURCES, INC.

ARTICLE II

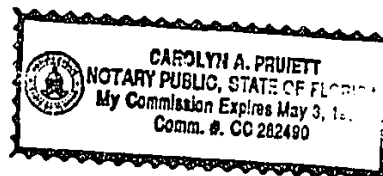
