The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is ASHBERRY WATER CONDITIONING, INC.

ARTICLE II

BUSINESS AND POWERS

- A. The general nature of the business or businesses to be transacted by the Corporation is water conditioning end to engage in any activity or business permitted under the laws of the United States and the State of Florida.
- B.
