ARTICLES OF INCORPORATION  
OF  
DOMINION TECHNOLOGIES CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I.

The name of the corporation shall be Dominion Technologies Corporation.

ARTICLE II.

The corporate existence of the corporation shall begin March 25, 1997.

ARTICLE III.

The address of the principal office of the corporation shall be 3625 Century Boulevard, Lakeland, Florida 33811, and the mailing address of the corporation shall be P O Box 6159, Lakeland, Florida 33807.

ARTICLE IV.

Section 1. The aggregate number of shares which the corporation shall have authority to issue is 1,000,000 shares, consisting of 500,000 shares of Class A Common Stock having a value of \$0.01 per share and 500,000 shares of Class B Common Stock having a value of \$0.01 per share.

Section 2. The following is a statement of the preferences, limitations, and relative rights in respect of the shares of the Class A Common Stock and the shares of the Class B Common Stock: The shares of the Class A Common Stock shall have equal rights with the shares of the Class B Common Stock except that the shares of the Class B Common Stock shall have no right to vote.

ARTICLE V.

The street address of the corporation's initial registered office is 3625 Century Boulevard, Lakeland, Florida 33813, and the name of its initial registered agent at that office is Brett Courier.

ARTICLE VI.

The name and address of the sole incorporator of the corporation is Brett Courier, 3625 Century Boulevard, Lakeland, Florida 33811.
