WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST: The name of the corporation is Rotonda Laundromat & Dry Cleaners Inc.
- SECOND: The period of its duration is perpetual
- THIRD: The purpose(s) for which the corporation is organized are to operate a
coin laundry + drop-off dry cleaning facility and any
other lawful business activity for which corporations
may be incorporated under Chapter 607 of the Florida Statutes.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is
100 shares of common stock. No par value.
