# ARTICLES OF INCORPORATION

0F

#### TATIANA RECOVERIES, INC.,

I the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE\_I

The name of this corporation shall be Tatiana Recoveries, Inc., and the initial address of this corporation shall be 12940 Calais Circle, Palm Beach Gardens, Florida.

## ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

# ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
