The undersigned, acting as incorporator of Casper Trading Company, under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is Casper Trading Company.

ARTICLE II

ADDRESS

The street address of this Corporation shall be 4061 Southwest 47th Street, Fort Lauderdale, Florida 33314.

ARTICLE III

DURATION AND COMMENCEMENT OF EXISTENCE

The duration of the Corporation shall be perpetual commencing on the date of filing of these Articles of Incorporation with the Secretary of State of Florida.

ARTICLE IV

PURPOSE

The purpose of the Corporation shall be to engage in any activities or business permitted under the laws of the United States and the State of Florida.
