## ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

### FIRST

The name of the corporation is: ULTRAMED Diagnostic Center, Inc.

### SECOND

The period of its duration is: Indefinitely.

### THIRD

The purpose of the Corporation is to engage in a variety of activities dealing with ultrasound medical diagnostics.

The foregoing purpose and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of the State of Florida.

### FOURTH

The aggregate number of authorized shares is : 100 common stock.

#### **FIFTH**

The corporation will not commence business until at least 1.00 per share dollars have been received by it as consideration for the issuance of shares.

#### **SIXTH**

Cumulative voting of 100 shares of common stock is authorized.

#### **SEVENTH**

Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are : none

#### **EIGHTH**

Provisions for regulating the internal affairs of the corporation are contained in the bylaws.

#### **NINTH**
