## WRITTEN CONSENT TO ACTION BY THE SHAREHOLDERS OF SOUTHWEST CONSUMER CREDIT, INC.

# AUTHORIZING DISSOLUTION OF THE CORPORATION AND ADOPTING A PLAN OF LIQUIDATION & DISSOLUTION

The undersigned being all of the Shareholders of SOUTHWEST CONSUMER CREDIT, INC., a Florida Corporation, acting in accordance with Section 607.0704 of the Florida Business Corporation Act, hereby waive all notice of time, place or purpose of meeting and approve, adopt, and take the following actions by means of this written consent:

WHEREAS, the Shareholder(s) has/have determined that it is advisable and beneficial for the Corporation that it be liquidated and dissolved; and

WHEREAS, the Shareholder does hereby adopt a Plan of Liquidation and Dissolution for the Corporation;

RESOLVED: That the following Plan of Liquidation is adopted to assemble and marshal the assets of the Corporation, pay or make adequate provision for the debts of the Corporation, and to distribute any remaining assets of the corporation:

- 1. The Corporation shall be liquidated pursuant to Section 331 of the Internal Revenue Code and Section 607.1402(6) of the Florida Statutes.
- 2. All liabilities and obligations of the Corporation will be paid or discharged, or adequate provision will be made for them.
- 3. The sole Officer and Director of the Corporation is authorized to sell or otherwise liquidate all of the properties and assets of the Corporation that she deems necessary or advantageous to facilitate the liquidation of the Corporation.
- 4. The sole Officer of the Corporation is authorized to do any and all things necessary or convenient to carry these Resolutions into effect, including, but not limited to, the following:
  - (a) Executing any and all instruments of conveyance;
  - (b) Paying all taxes and fees;
  - (c) Executing all documents required by law to be filed;
  - (d) Retaining professional advisors; and

- (e) Doing all other things necessary or convenient to effect the dissolution of the Corporation.
- 5. After the provision for, or payment of, the known debts and liabilities of the Corporation, the sole Officer is authorized and directed to distribute the remaining cash or other assets of the Corporation to the sole Shareholder of record according to her respective rights and interests in exchange for her shares in the Corporation.
