ARTICLES OF INCORPORATION

OF

FIRPO ENTERPRISES, INC.

THE UNDERSIGNED acting as Incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I
(NAME)

The name of the Corporation is FIRPO ENTERPRISES, INC.

ARTICLE II
(DURATION)

The Corporation shall have perpetual existence.

ARTICLE III
(PURPOSE)

The Corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under the laws of the state of Florida.

ARTICLE IV
(CAPITAL STOCK)

The Corporation is authorized to issue 7,500 shares of One Dollar (\$1.00) par value Common Stock.

ARTICLE V
(PRINCIPAL PLACE OF BUSINESS, MAILING ADDRESS,
(INITIAL REGISTERED OFFICE AND AGENT))

The principal place of business and mailing street address of

ARTICLE VI
(INITIAL BOARD OF DIRECTORS)

The Corporation shall initially have two (2) directors to hold office until the first annual meeting of shareholders and their successors shall have been duly elected and qualified, or until their earlier resignation, removal from office or death. The number of directors may be either increased or decreased from time to time in accordance with the By-Laws of the Corporation. 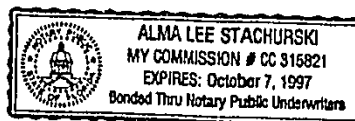
