In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is KAUFFMAN & ASSOCIATES, INC.

ARTICLE II

The existence of the Corporation shall begin on the filing of these Articles of Incorporation and shall continue perpetually.

ARTICLE III

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

The street address of the principal office of the Corporation is 579 Ridgewood Drive, Windermere, Florida 34786.

ARTICLE V
