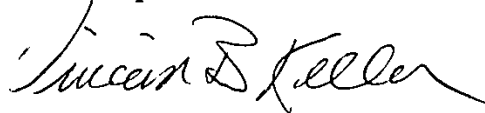
Dear Bobbie,

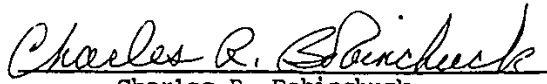

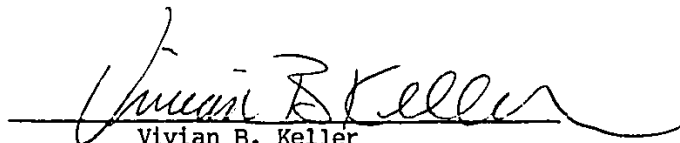
