ARTICLES OR INCORPORATION
OF
PAMELA RAMA M.D., P.A.

The undersigned subscriber to these Articles of Incorporation, is a natural person competent to contract, hereby associates to form a corporation under the State of Florida and hereby does adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of this corporation is: Pamela Rama M.D., P.A.

ARTICLE II
NATURE OF BUSINESS

This Corporation is organized for the following purposes:

1. To engage in every aspect of the practice of medicine and all its fields of specialization as are engaged in by doctors in this state.
2. To engage and render the professional service involved only through its officers, agents and employees who are doctors in good standing and duly licensed or otherwise legally authorized within the State of Florida to render professional the service of this corporation.
3. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
4. To own real and personal property necessary for rendering of professional services hereby authorized.
5. To engage in no other business other than rendering of the professional services herein specified.

ARTICLE III
CAPITAL STOCK

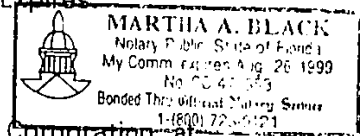

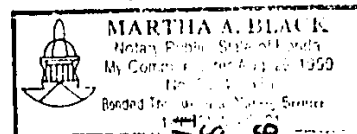
