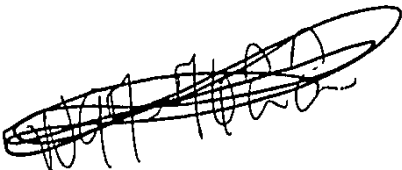

ARTICLES OF INCORPORATION  
OF

I, the undersigned, hereby make, subscribe, acknowledge and file the following Articles for the purpose of forming a Corporation under the Laws of the State of Florida.

ARTICLE I. CORPORATE NAME

The name of this Corporation is RICH STRINGER, ATTORNEY-AT-LAW, CHARTERED.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation in accordance with the limits of Florida Statutes 621 is to provide professional legal services as an attorney.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV. TERM OF EXISTENCE

This Corporation shall exist perpetually.

ARTICLE V. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

#### ARTICLE XII. INDEMNIFICATION

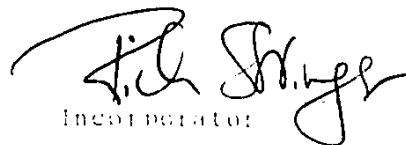

#### ARTICLE XIII. COMPENSATION

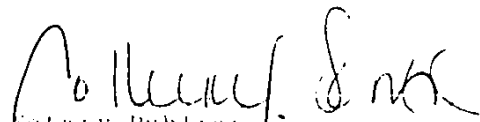

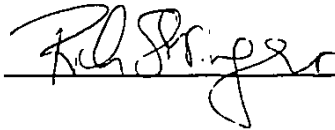

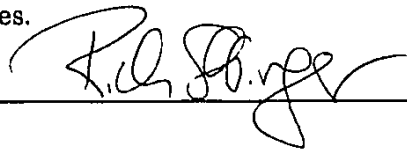
