ARTICLE I
CORPORATE NAME

The name of this corporation is **THE ENGET INSTITUTE OF HOLISTIC

ARTICLE II
INITIAL PRINCIPAL PLACE OF BUSINESS

NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to
