ARTICLES OF INCORPORATION

The undersigned incorporators make, subscribe, acknowledge, and file with the Department of State of the State of Florida the Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I: NAME

The name of this Corporation is **Maple Distribution Centers, Inc.**, with a principal office and mailing address of 5001 L.B. McLeod Road, Orlando, Florida 32811.

ARTICLE II: TERMS OF EXISTENCE

This Corporation shall commence as of the date of the completed execution, acknowledgment, and filing date by the Secretary of State of Florida of these Articles and shall have perpetual existence.

ARTICLE III: NATURE OF BUSINESS
