ARTICLES OF INCORPORATION  
OF  
LEONARDO RAFAEL PAINT & BODY, INC.

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Leonardo Rafael Paint & Body, Inc., and its address is 1950 West 54 Street, #414, Hialeah, Florida 33012.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are:

- (1) To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

AUTHORIZED SHARES

The aggregate number of shares which the corporation is authorized to issue is 1,000. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

## ARTICLE V

### REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 1950 West 54 Street, #414, Hialeah, Florida 33012, and the name of its initial registered agent at such address is Leonardo Rafael.

## ARTICLE VI

### DIRECTORS

The number of directors constituting the board of directors of the corporation shall be determined in accordance with the By-Laws, but shall not be less than one. 



ACKNOWLEDGEMENT OF APPOINTMENT OF REGISTERED AGENT


