**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Sections 607.1003, 607.1006 and 621.13 of the Florida Statutes, Ramon Pineda Pediatrics, P.A. hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Ramon Pineda Pediatrics, P.A.
2. The original Articles of Incorporation for the Corporation were filed on April 11, 1997, and assigned Document P97000033480.
3. Article I of the Articles of Incorporation is hereby amended to read as follows:

4. Article II of the Articles of Incorporation is hereby amended to read as follows:

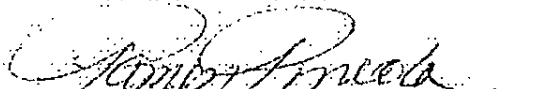
ARTICLE II: PURPOSE

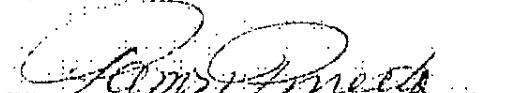
The Corporation is formed for the purpose of engaging in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.
