The undersigned, acting as incorporator of a corporation under the Laws of the State of Florida, adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is COL-TRE', INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to provide landscape and lawn care services to the public and engage in any activities, conduct any business or businesses permitted under the laws of the United States, the State of Florida, or any state in which it may then be currently registered or conducting business.

ARTICLE IV - CAPITAL STOCK

The total number of shares that the corporation has authority to issue and have outstanding at any time is 1000 shares of a single class of common stock having a par value of one dollar (\$1.00) per share.


ARTICLE V - PREEMPTIVE RIGHTS

The holders of the common stock of this corporation shall have preemptive rights purchase at prices, terms, and conditions that shall be fixed by the Board of Directors, those shares of the common stock of this corporation which may be issued from time to time for money, property, or past services in addition to that

above, I hereby agree to act in this capacity, and I further agree to comply with the provisions of all statutes relative to the proper and complete performance of my duties, and I state that I am familiar with and accept the duties and obligations imposed on me by Section 607.325 of the Florida General Corporation Act.
