BY THESE ARTICLES the incorporator forms a corporation under the Business Corporations Act:

1. NAME. The name of this corporation is LM NOLL CORPORATION.
2. PRINCIPAL OFFICE. The address of the principal office of this corporation is 4343 Clark Rd. Sarasota, Florida 34233 and its mailing address is the same.
3. CAPITAL STOCK. This corporation is authorized to issue one class of common stock comprising 1000 shares of common stock with no par value and unlimited voting rights that are entitled to receive the net assets of the corporation on dissolution.

7. PURPOSE. The corporation is formed for the purpose to engage in any and all lawful business.

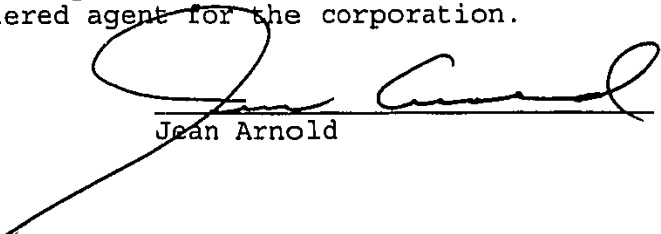
