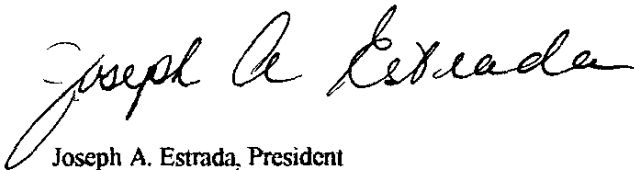
- Our principal place of business and our mailing address are both listed incorrectly. We moved the middle of last year. Our current address (for both) is:
