#### **ARTICLE VIII PREEMPTIVE RIGHTS**



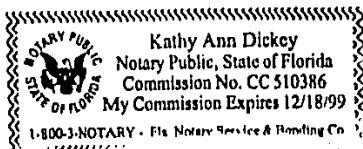
