ARTICLES OF INCORPORATION OF FAIRBANKS AUTO CENTER, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE 1 - NAME AND ADDRESS

The name of the Corporation is: Fairbanks Auto Center, Inc. The principal office of the Corporation is 2617 West Fairbanks Avenue, Winter Park, Florida 32789, and the mailing address of the Corporation is the same.
