ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation,
adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Star Sports Enterprises, Inc.,

DURATION

The duration of the corporation is perpetual.




