ARTICLE I
Name and Principal Office

The name of this corporation is F & V ROSE ENTERPRISES, INC.
The principal place of business and mailing address of this corporation is 4425 NE Third Court, Ocala, FL 34479.

ARTICLE II
Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III
Purpose

This corporation is organized for the purpose of transacting any and all lawful business, except that this corporation is not authorized to engage in the business of banking, insurance or engineering.

ARTICLE IV
Capital Stock

The maximum number of shares of stock of this corporation is authorized to have outstanding at any one time is Five Hundred (500) Shares of common stock, with a par value of One (\$1.00) Dollar per share. The shares of the corporation are not to be divided into classes and the corporation is not authorized to issue shares in series.

ARTICLE V
Preemptive Rights

Every shareholder, upon the sale for cash of any authorized and unissued common stock of this corporation, shall have the right to purchase his/her prorata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI

Initial Registered Office and Agent





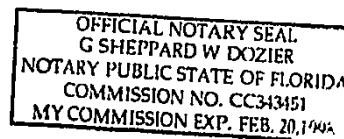
