I. NAME AND MAILING ADDRESS

II. TERM OF EXISTENCE



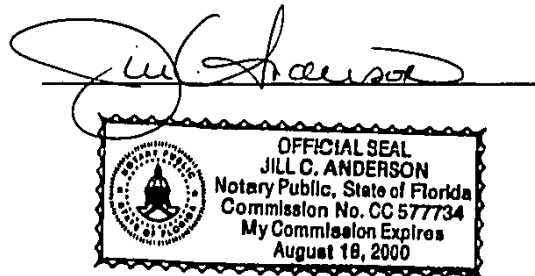


