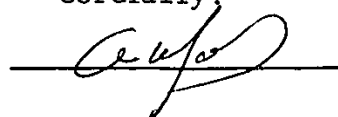

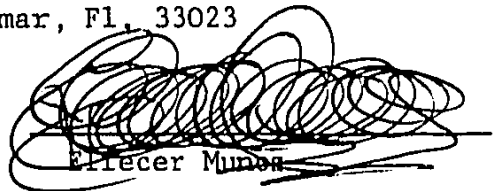

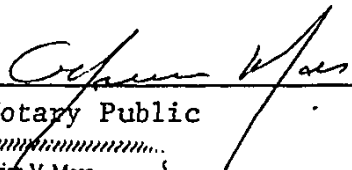
BY THESE ARTICLES OF INCORPORATION the incorporator forms

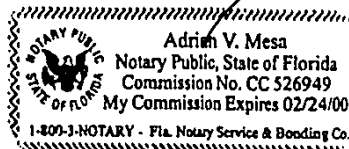

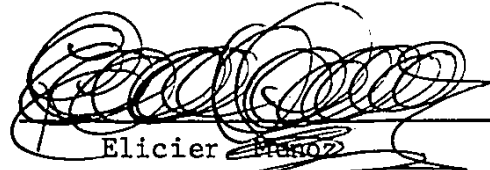
