Plan of Share Exchange dated December 28, 2000 between Sofiseb U.S.A., Inc., a Florida corporation (hereinafter the "Company"), the Company's wholly owned subsidiary, Arthur Bonnet Boca Raton, Inc., a Florida corporation (hereinafter the "Subsidiary") and Bactel Inc., a Bahamian corporation (hereinafter the "Bactel").

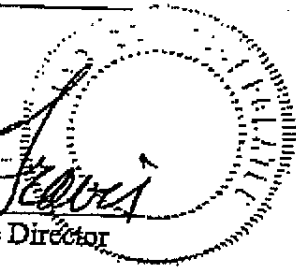
