## ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

### Article I- Corporation Name and Mailing Address:

The name of the corporation is Pfersich & Wolfson Consultants, Inc., and the mailing address is 1400 S.W. 80th Street Ocala, Fl. 34476.

### Article II- Term of Existence:

The existence of the corporation shall begin upon the filing of the Articles with the Secretary of State and it shall continue to exist in perpetuity unless sooner dissolved according to law.


