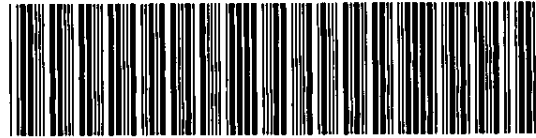

Pursuant to the provisions of Section 607.1006(1) of Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is Friendly Computer Services, Inc. and its Document Number is P97000034393.

2. The following amendments to the Articles of Incorporation were adopted by the Directors of the Corporation on the 15th day of January, 2015, in the manner prescribed by Florida Statutes:

Article 1 - is hereby amended by deleting the first sentence in order to change the corporate name as follows:

"The name of this Corporation shall be JNIT, INC."

3. This amendment was adopted by the Board of Directors without shareholder action and shareholder action was not required. The number of votes cast for the amendment by the Directors was sufficient for approval.
