BEFORE ME, the undersigned authority, this day personally appeared Marlene Marban who first by me being duly sworn deposes and says:


That pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

First: Be it amended that Article VII of the Articles of Incorporation has been changed to correct Marlene Marban as President, Vice-President Secretary, Treasurer and Director of the corporation.

Second: Be it amended that the corporation officers are hereby changed and shall hereafter be known as Marlene Marban as President, Vice-President Secretary, Treasurer and Director of the corporation.
