ARTICLES OF INCORPORATION

1. The name of the Corporation shall be and is:

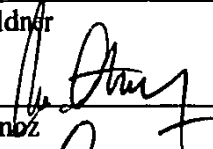

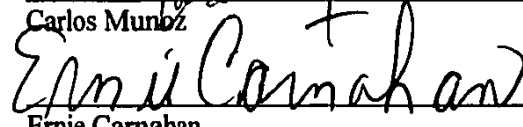
