**ARTICLES OF INCORPORATION  
OF  
ALIVE PUBLICATIONS, INC.**

**ARTICLE I - Name**

The name of this corporation is **ALIVE PUBLICATIONS, INC.**

**ARTICLE II - Duration**

This corporation shall have perpetual existence.

**ARTICLE III - Purpose**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV - Capital Stock**

This corporation is authorized to issue 7,500 shares of One Dollar (\$1.00) par value common stock.

**ARTICLE V - Initial Street Address**

The street address of the initial principal office of this corporation is 810 Oak Road, Ocala, Florida 34472, and the name of the initial registered agent of this corporation is Samuel J. Bond.

**ARTICLE VI - Initial Board of Directors**

ARTICLE VII - Incorporator

ARTICLE VIII - By-laws

The power to adopt, alter, amend or repeal by-laws shall be vested in the shareholders.

ARTICLE IX - Indemnification

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE X - Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE XI - Registered Agent
