The undersigned incorporator, for the purpose of forming a corporation (hereinafter referred to as the "Corporation") under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

**Article I:** The name of the corporation shall be **FIRST RESIDENTIAL MORTGAGE CORP.**

**Article II:** The principal place of business and mailing address of this corporation shall be 662 Mourning Dove Drive Sarasota, FL 34230

**Article III:** The number of shares of stock that the corporation is authorized to have outstanding at any one time is 1000, all of which are without par value and classified as Common shares.



**Article VI:** The purposes for which the corporation is organized are to engage in any lawful business for which corporations may be incorporated under the provisions of the Florida Statutes.

**Article VII:** The period of duration of the corporation is perpetual.

**Article VIII:** The corporation shall, to the fullest extent legally permissible under the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, shall indemnify and hold harmless any and all persons whom it shall have power to indemnify under said provisions from and against any and all liabilities (including expenses) imposed upon or reasonably incurred by him in connection with any action, suit or other proceeding in which he may be involved or with which he may be threatened, or other matters referred to in or covered by said provisions both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director or officer of the corporation. Such indemnification provided shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, Agreement or Resolution adopted by the shareholders entitled to vote thereon after notice.

The undersigned incorporator has executed these Articles of Incorporation this 17th day of April, 1997.


