ARTICLE I - NAME

The name of this Corporation is **ICE CONCEPTS ENTERTAINMENT, INC.**

ARTICLE II - INITIAL PRINCIPAL OFFICE

The initial principal office of this Corporation is 102 Springhurst Circle, Lake Mary,
Florida 32746.

ARTICLE III - DURATION

The Corporation shall have a perpetual existence.

ARTICLE IV - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under
the Laws of the United States and Florida.

ARTICLE V - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding

case shall the number of directors be less than one (1) nor more than nine (9). The name




