The undersigned, acting as incorporator, signs and adopts the following Articles of Incorporation for the purpose of forming a corporation under the Professional Service Corporation Act of the State of Florida.

ARTICLE I

The name of the corporation shall be: CABLE WORLD INCORPORATED.

ARTICLE II

The existence of the corporation shall commence upon the filing of these Articles of Incorporation by the Department of State and shall be perpetual.

ARTICLE III

The Corporation may engage or transact in any and all lawful activities or business permitted under the laws of the United States, the State of Florida or any other State, Country, Territory or Nation.

The maximum number of shares of stock which the corporation is

The number of directors may be increased or decreased from time to time pursuant to the bylaws of the corporation, but shall not be less than one.

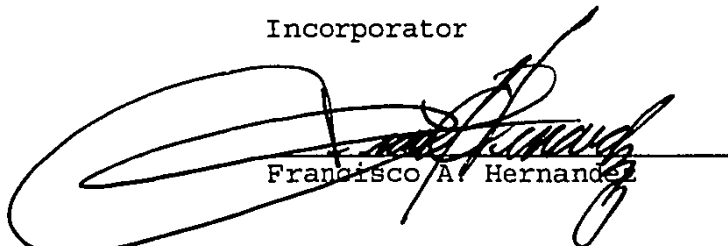

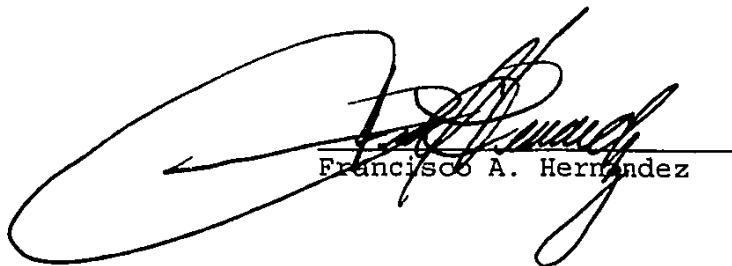
